# When is alcohol an alcoholic beverage in Montana?

#### Alcoholic beverage defined in Montana

"Alcoholic beverage means a compound produced and sold for human consumption as a drink that contains more than 0.5% of alcohol by volume (abv)." 16-1-106 (3), MCA.

Ethyl alcohol (ethanol) is the chemical name of the compound found in alcoholic beverages. It is the only type intended for consumption and the only kind of alcohol found in nature. Different types of alcoholic beverages contain different amounts of alcohol, and how alcohol is made will define how it is categorized.

## Examples of what are NOT alcoholic beverages that contain alcohol:

- Extracts (like vanilla extract)
- Tinctures (herbal/homeopathic extracts)
- Kombucha (under 0.5% abv)
- Some liquid cough medicines
- Mouthwash
- Other drinks under 0.5% abv, like NA beer and wine

# The three types of defined alcoholic beverages for drinking are: Beer, Wine, and Liquor

# Beer defined: 16-1-106 (5), MCA

**Beer** is a fermented beverage <u>made from</u> malted barley, water, hops, and yeast. Its alcohol content is 14% or lower.

## Type of Beer: Malt Beverage defined: 16-1-106 (21), MCA

A stronger version of beer, often with a higher alcohol content.

- A malt beverage containing 0.5 8.75% abv (considered "beer")
- Spike lemonades and iced teas
- "Margaritas" without tequila
- Malt "liquor" (i.e., hard seltzers)

# Wine defined: 16-1-106 (38), MCA

**Wine** is defined as "an alcoholic beverage <u>made from or containing</u> the normal alcoholic fermentation of the juice of sound, ripe fruit or other agricultural products without addition or abstraction, except as many occur in the usual cellar treatment of clarifying and aging, and that contains more than 0.5% but not more than 24% of alcohol by volume."

#### Types of Wine: Hard Cider, Table Wine, and Sacramental Wine

**Hard Cider** – an alcoholic beverage  $\underline{\mathbf{made from}}$  the fermentation of juices from apples or pears containing 0.5 - 8.5% of abv (includes cider), and may include flavoring, be "sparkling" or carbonated.

**Table Wine** – an alcoholic beverage containing 0.5 – 16% of abv.

**Sacramental Wine** – a wine that contains more than 0.5% but not more than 24% abv that is manufactured and sold exclusively for use as sacramental wine or other religious purposes. You must be licensed to sell this specific product only sold to churches.

Other examples may include Sake, Wine-based Cocktails, and Mead

# **Liquor defined: 16-1-106 (19), MCA**

All other alcoholic beverages that do not fit in the beer, malt beverage, or wine categories.

#### **Exceptions that are considered Liquor:**

- Wine 24% abv and above
- Beer 14% abv and above
- Malt Beverage 8.75% abv and above

#### Non-alcoholic (NA) Alcohol:

- NA Beverage drinks containing 0.5% or less abv
- The Alcoholic Beverage Control Division (ABCD) does not regulate any product with an abv of 0.5% and below

# What products must be approved?

- All out-of-state beer products
- All wine products
- All distilled products
  - o Distilled products go through a different process and will not show up in TAP
