
BILLS THAT DID NOT PASS

- HB315 introduced requiring a RBW licensee to obtain 70% gross income from the sale of food (instead of 65%); allowing the sale of alcoholic beverages to patrons at an RBW licensee regardless of whether they order food.
 - It would have allowed no requirement of the number of days a week to serve and evening meal; hours of no earlier than 8 am or later than 11 pm and serve beer & table wine for 12 consecutive hours.
- SB150 introduced to create a cigar room endorsement only for allbeverage licenses.
 - X It would have allowed for the smoking of premium cigars in a designated area indoors.

- SB195 introduced allowing a person who is at least 18 years of age but under the age of 21 to possess and consume beer or table wine.
 - It would have allowed a person 18 years of age but under the age of 21 with the consent and in the presence of the person's parent, legal guardian, or spouse who is 21 years of age or older, to possess and consume on a licensed premises with the consent of the licensee.
- HB407 introduced to establish DOR as the regulatory agency for Kratom.
 - It would have required registration of Kratom processors, distributors, and retailers; implement an excise tax, allow for penalties for violations; and allow the department to create rules.


