

How to apply for your Montana Property Tax Rebate on TAP

Application dates: August 15, 2025 - October 1, 2025

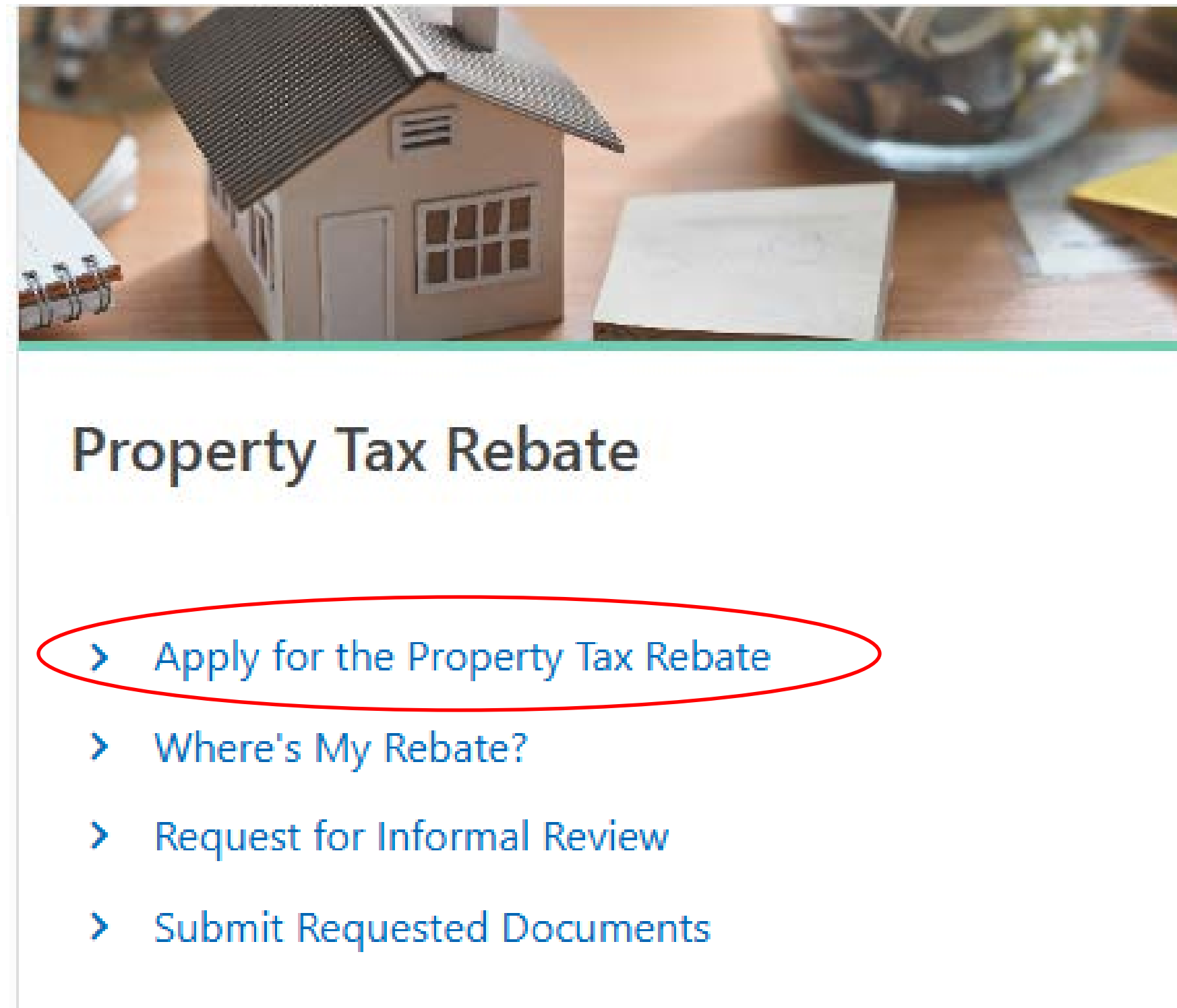

Under Property Tax Rebates, click on **Apply for the Property Tax Rebate**.



Fill out your Social Security Number. Fill out your Geocode. Your geocode is a 17-digit code that identifies your Montana property. Read the declaration and select the checkbox. Click **Continue**.

The deceased taxpayer must have owned and lived in the principal residence for at least seven months in addition to paying the property taxes on the residence. Attach federal Form 1310 identifying the personal representative. A surviving spouse must also complete federal Form 1310 to request a rebate if the spouse is not listed as an owner on the property tax bill or did not file jointly or separately on the same form on the 2024 Montana Individual Income Tax Return.
