## **VOLUNTARY PRODUCT RECALL**

The Montana Cannabis Control Division (CCD) is issuing product recalls for batches of cannabis that cannot be traced to their full panel of required testing.

The CCD identified this issue in late December of 2024. These products were available at various Montana-licensed dispensaries from approximately **09/14/2024** to **12/05/2024**.

CCD is utilizing the state's seed-to-sale tracking system to identify impacted inventory and is working in conjunction with Stokes, Sinful Beverages, to issue notices to licensees to halt further distribution and sale.
