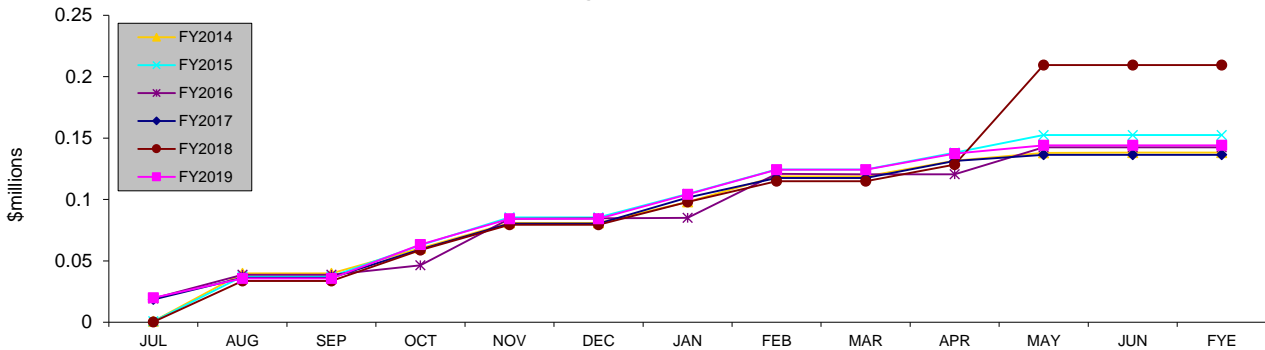

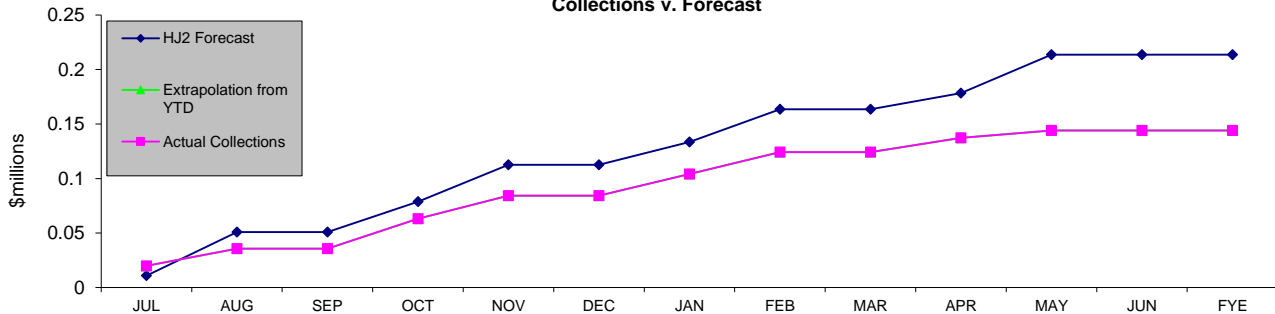

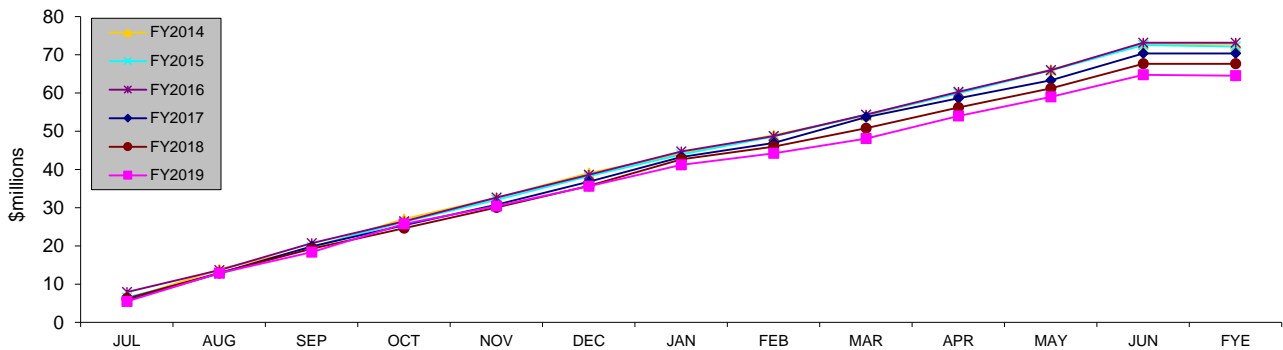

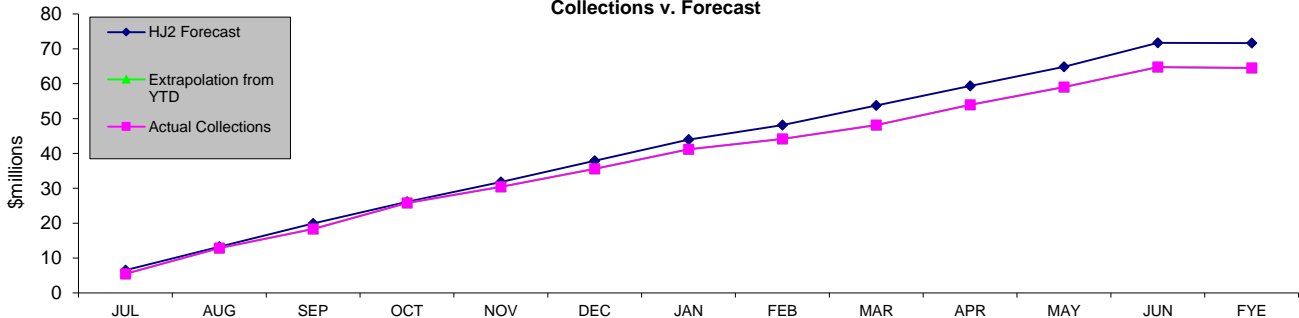

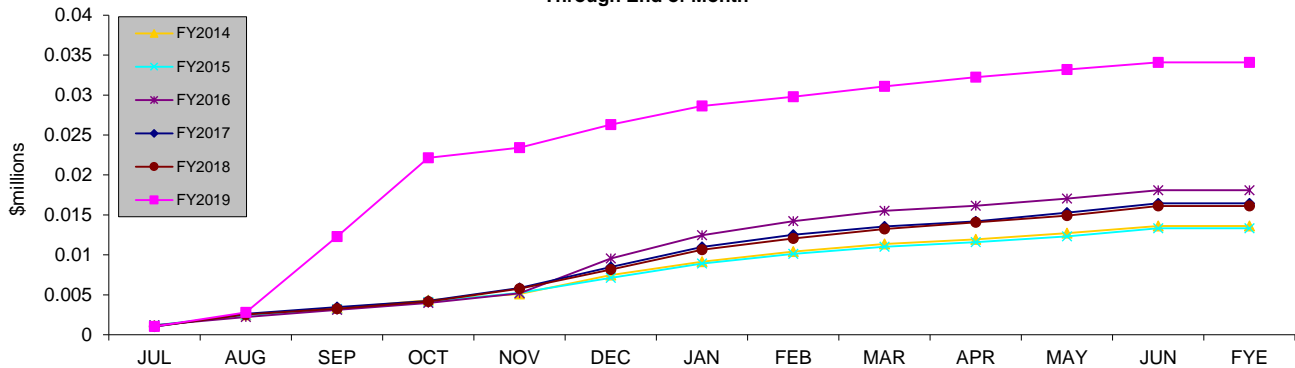

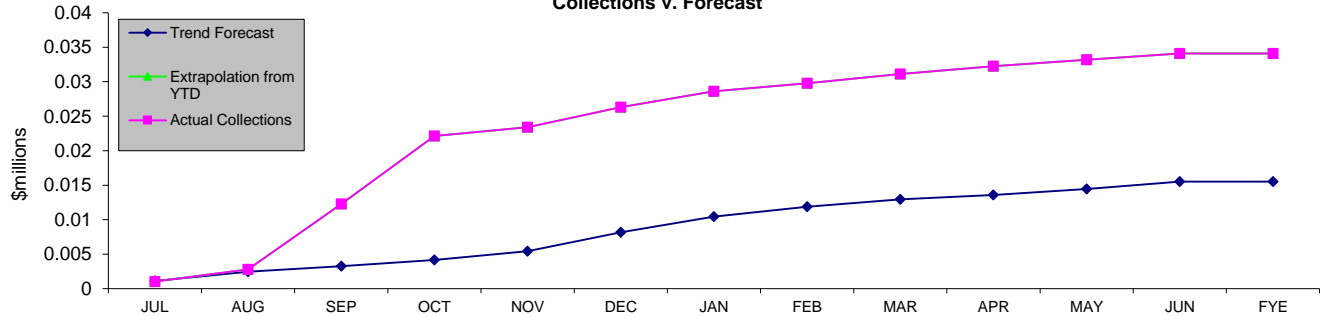

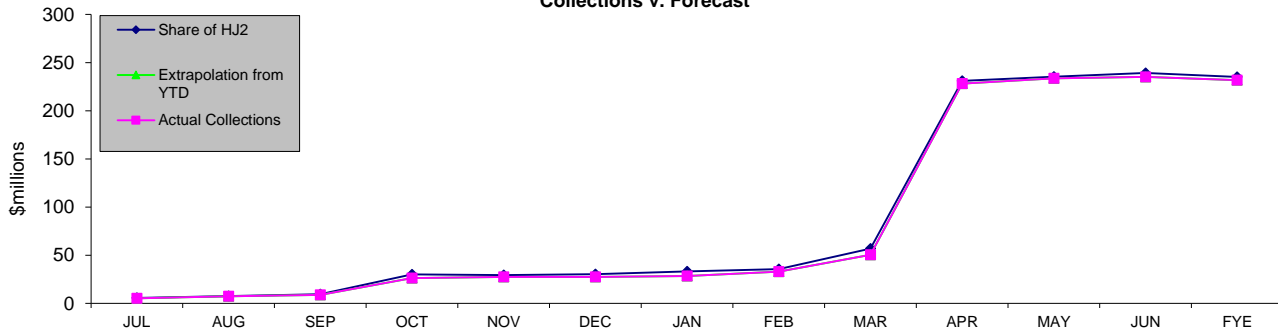

Income Tax - Current Year Tax Collections v. Forecast



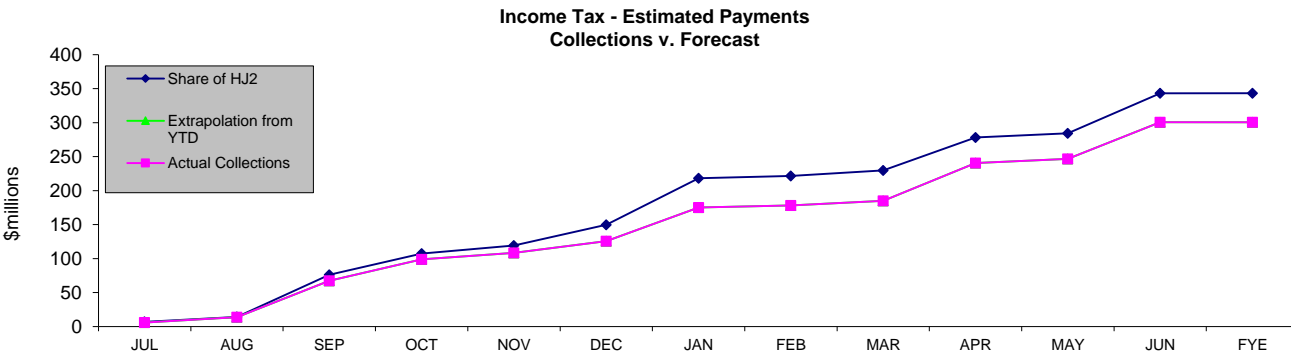
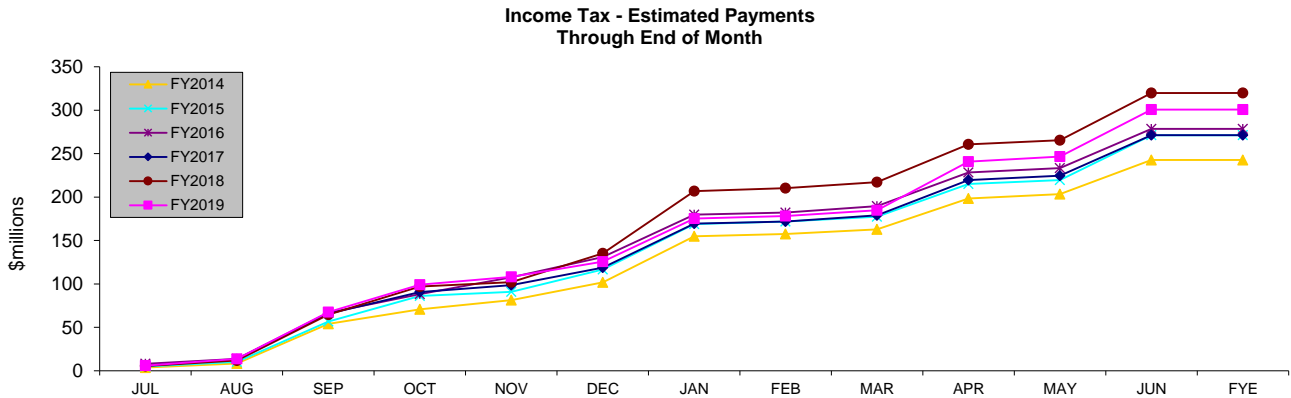

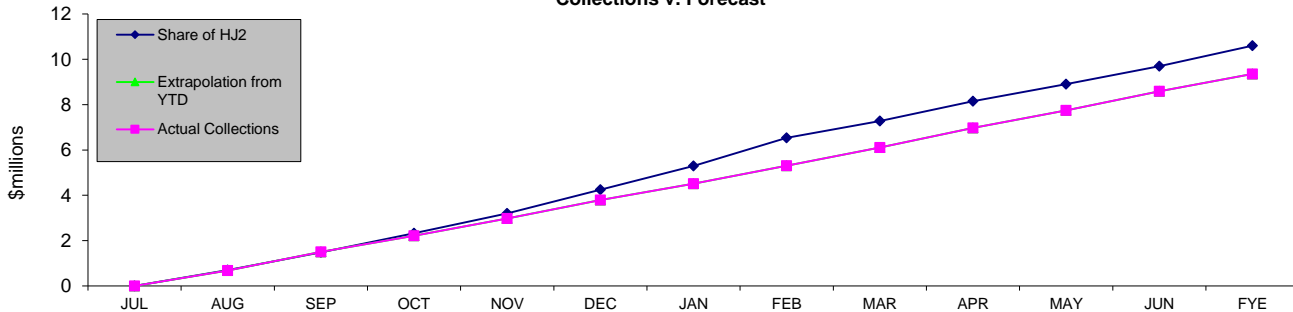

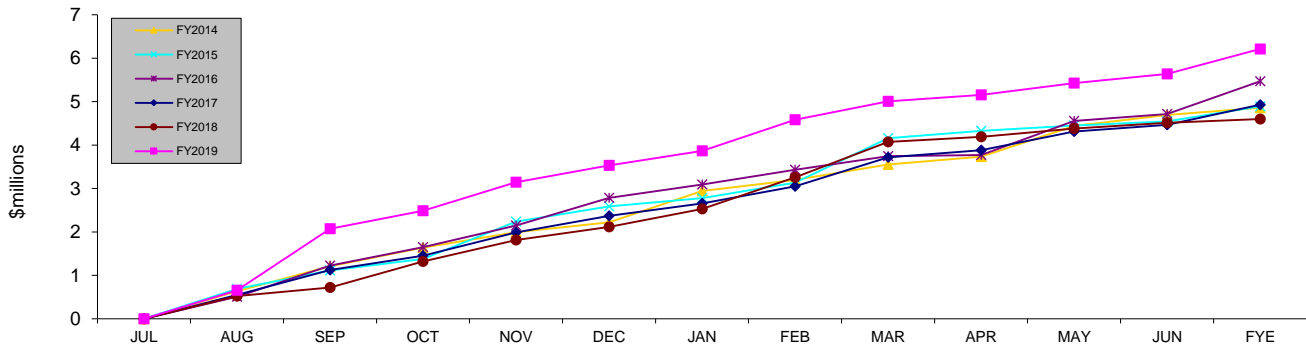

Income Tax - Prior Year/Amended Collections v. Forecast



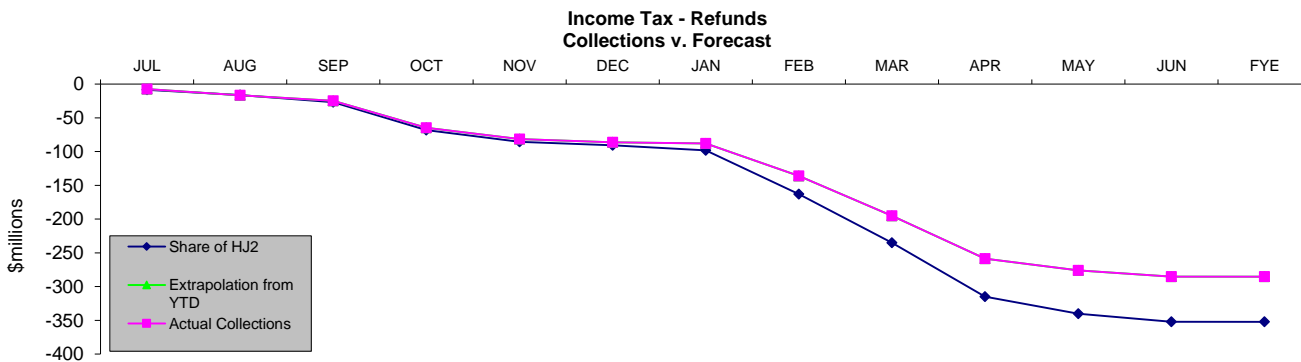
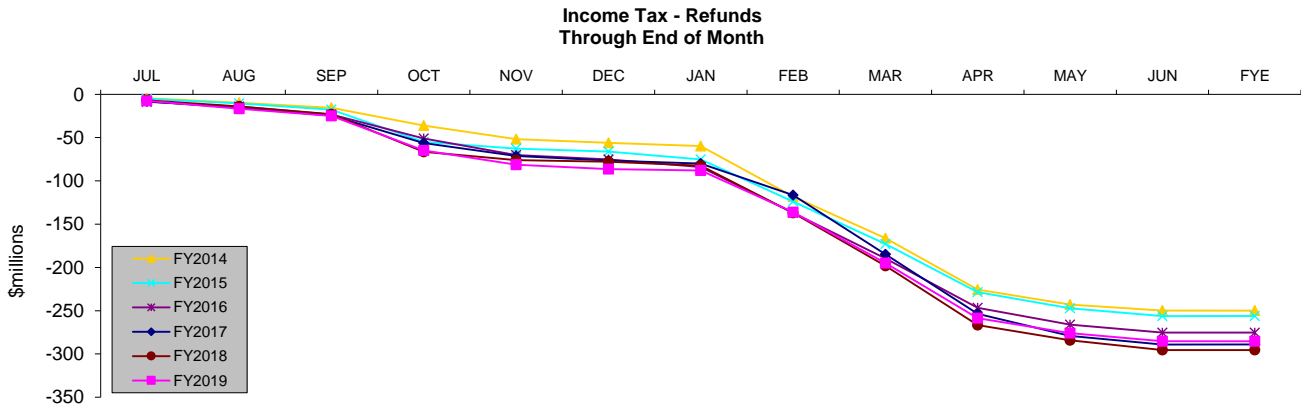

Income Tax - Withholding Collections v. Forecast



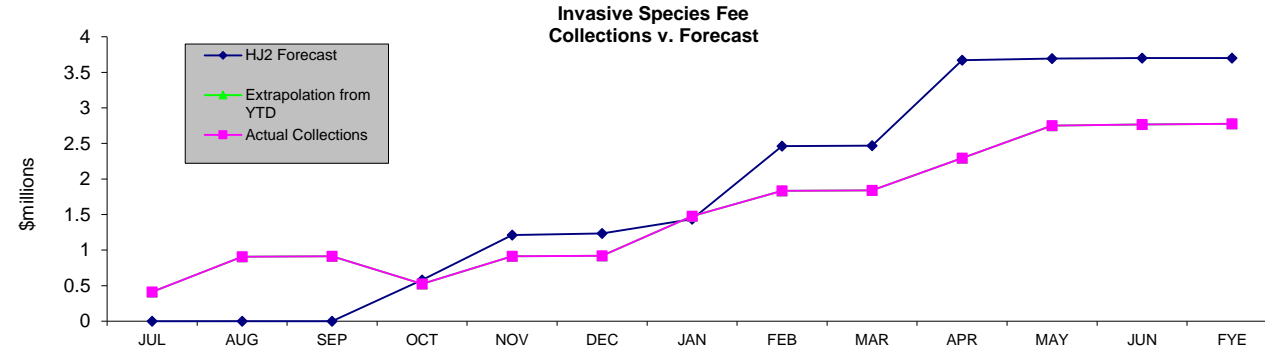
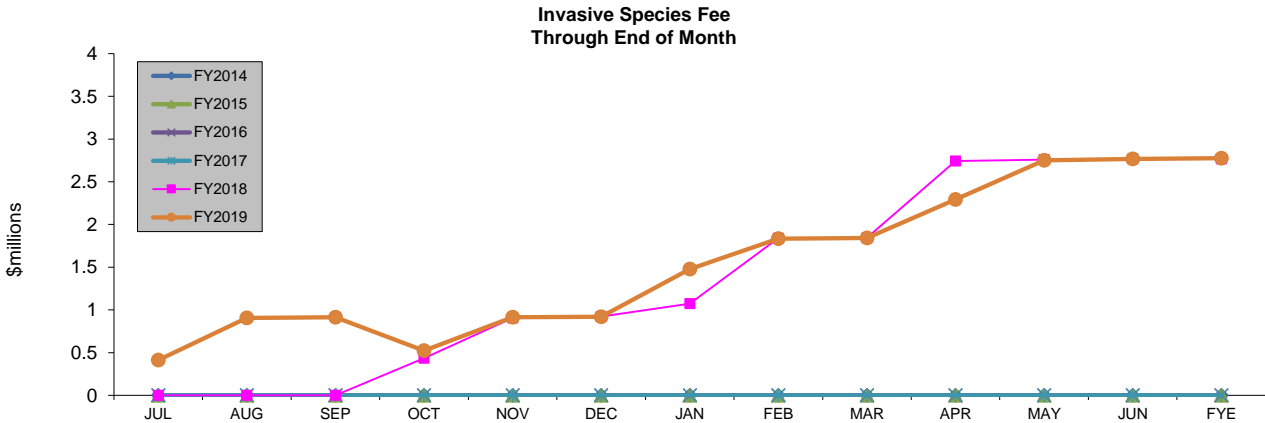

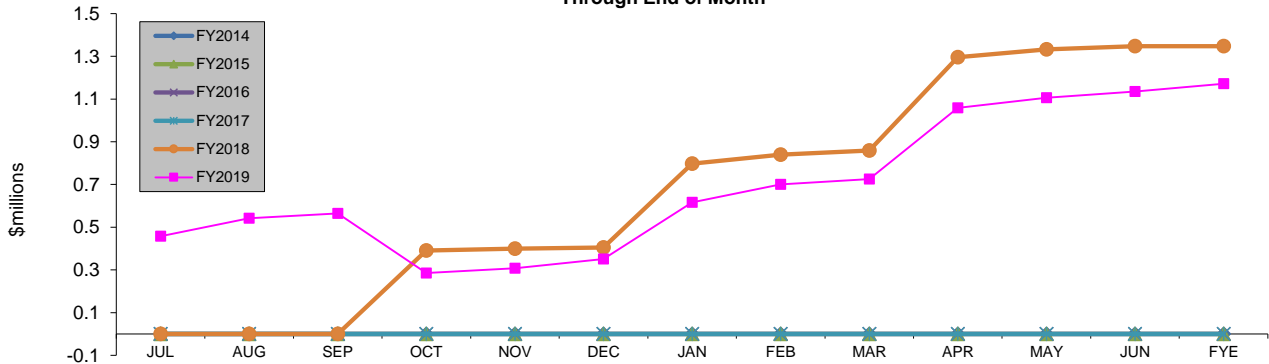

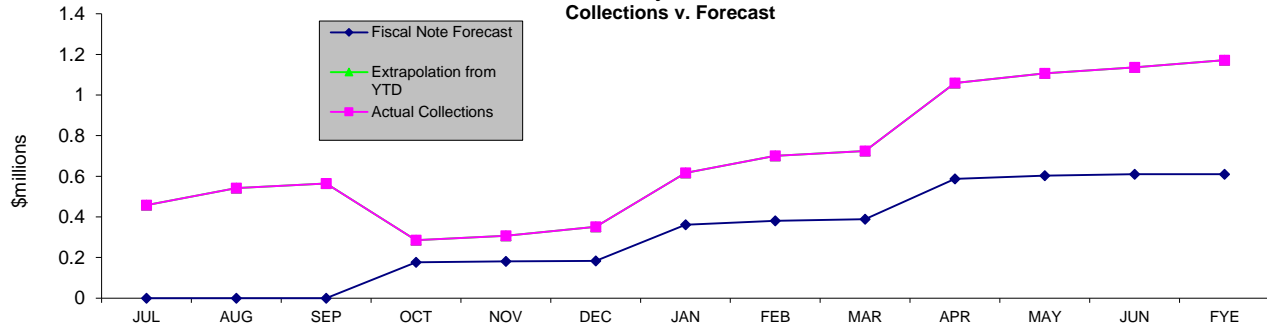

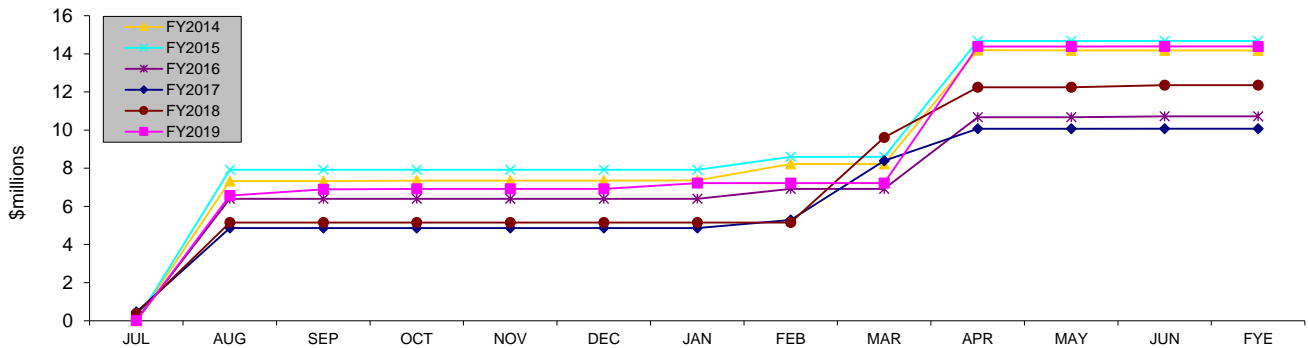
