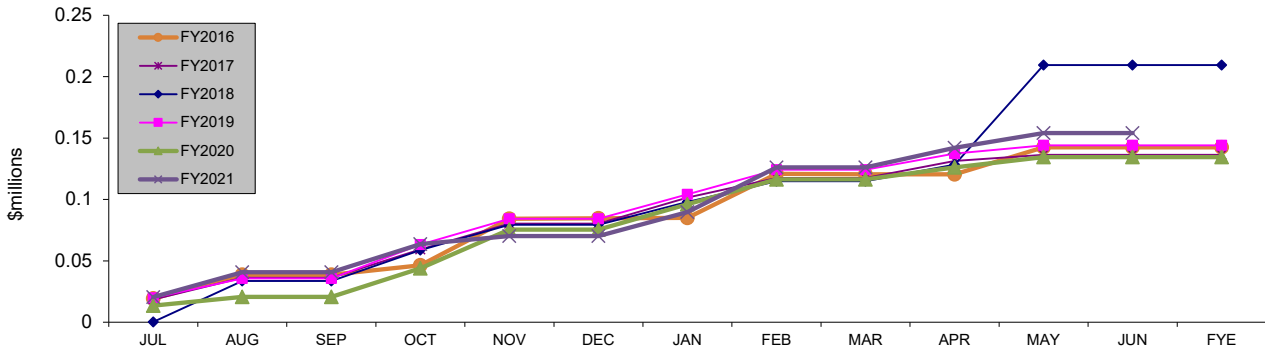

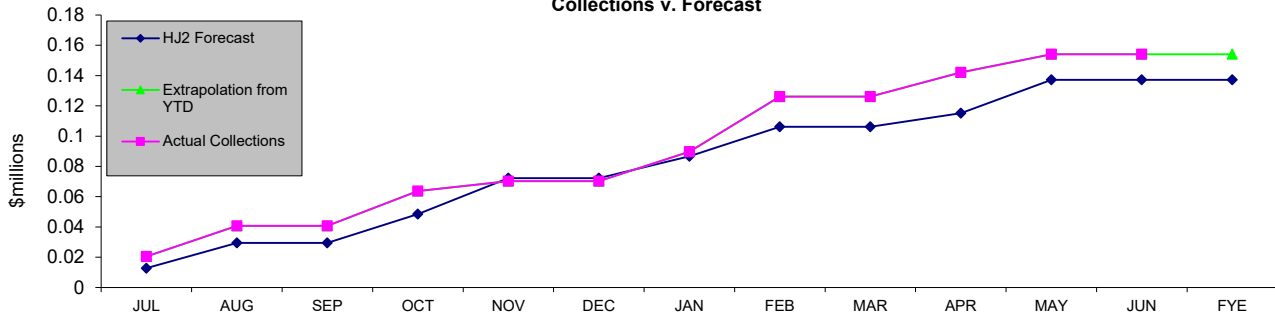

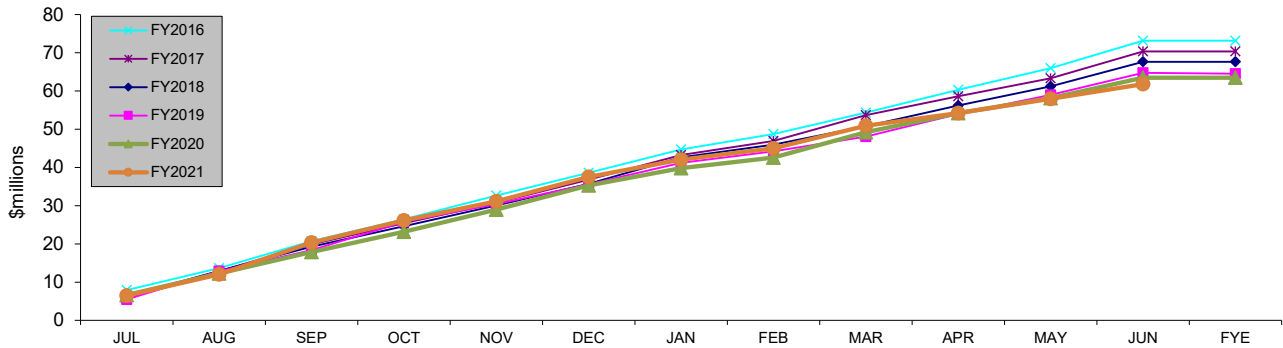

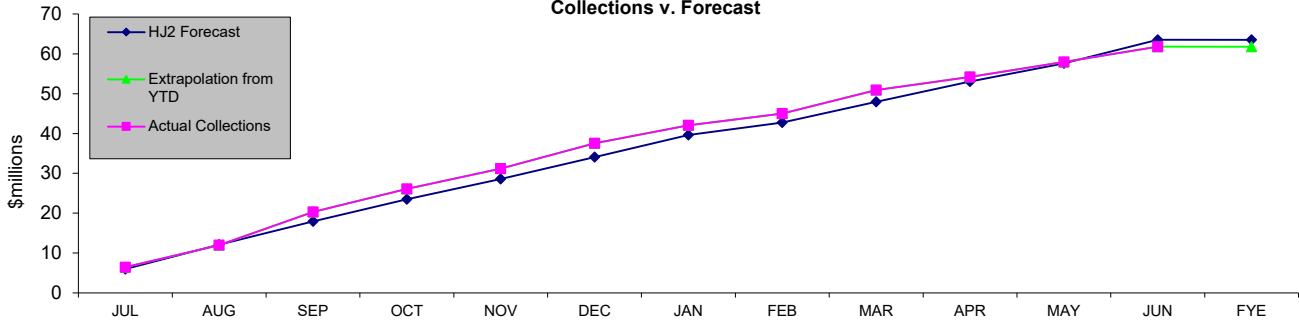

Collections v. Forecast**



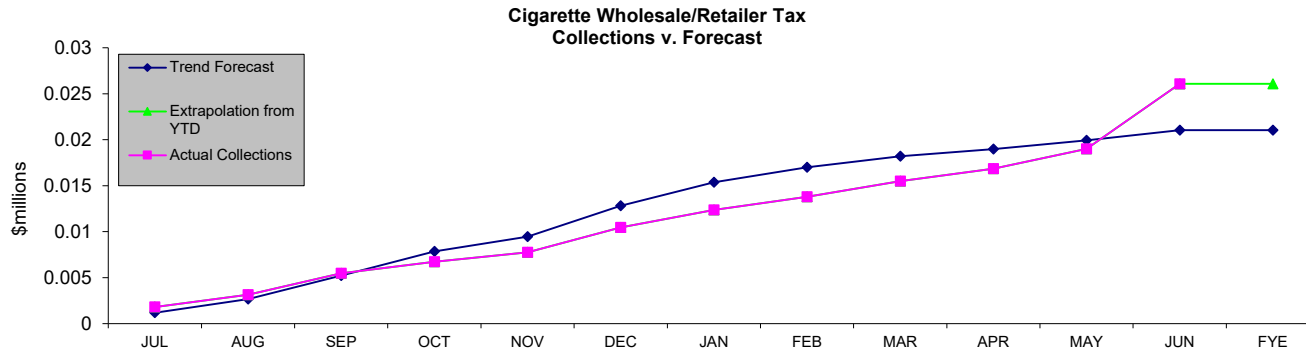
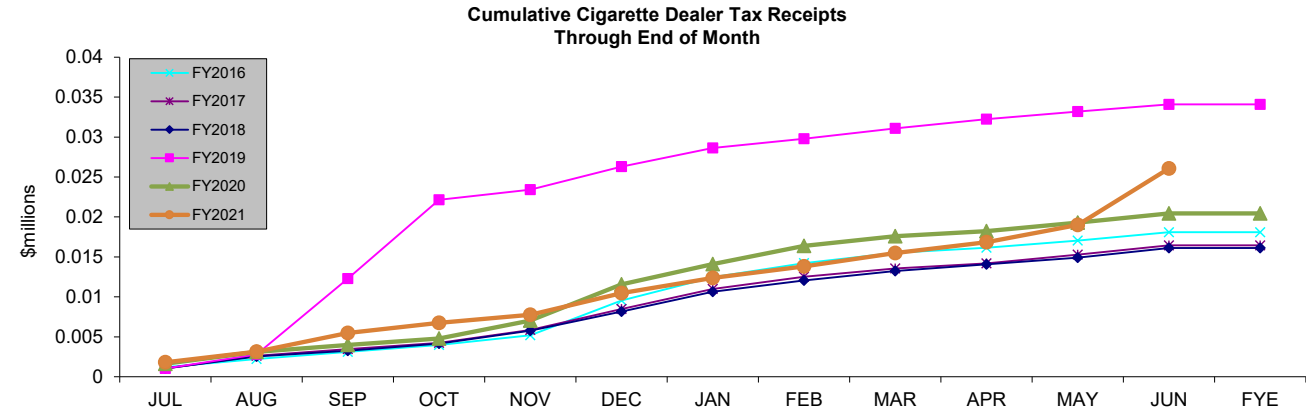

Collections v. Forecast**



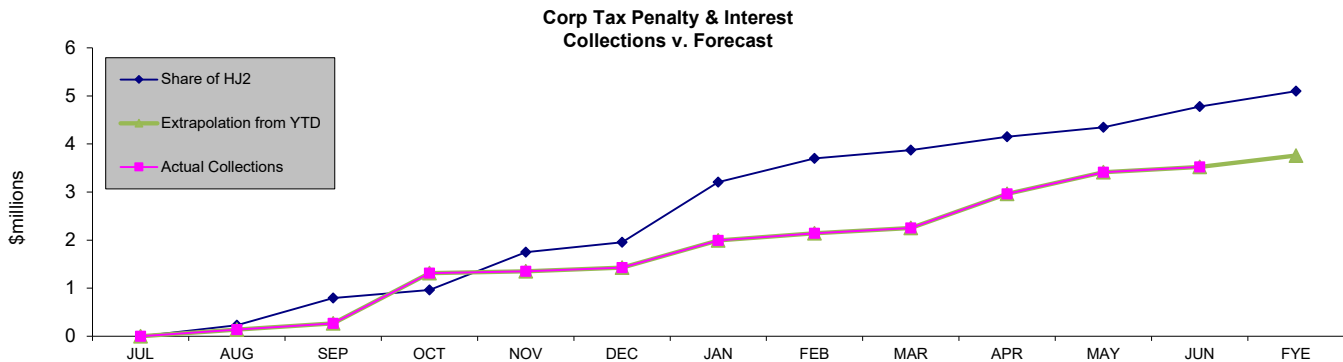
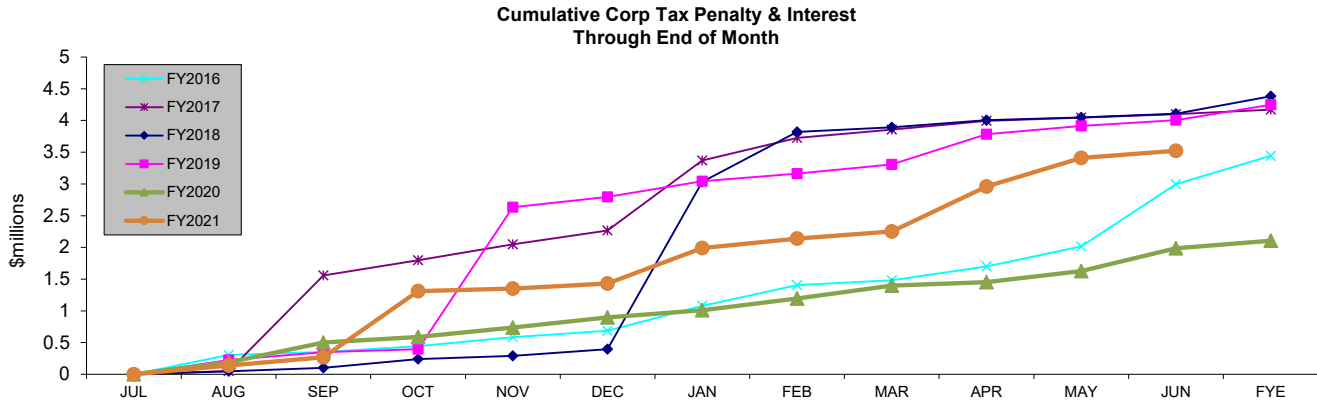

Collections v. Forecast**



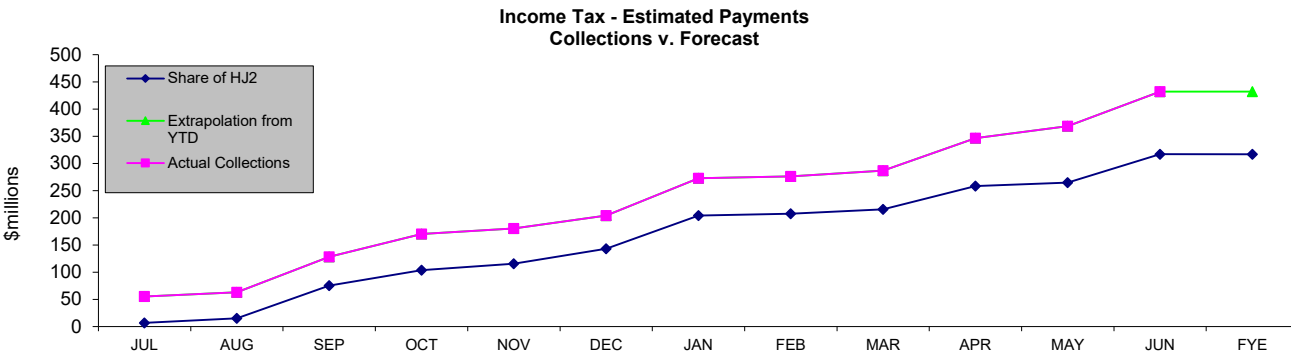
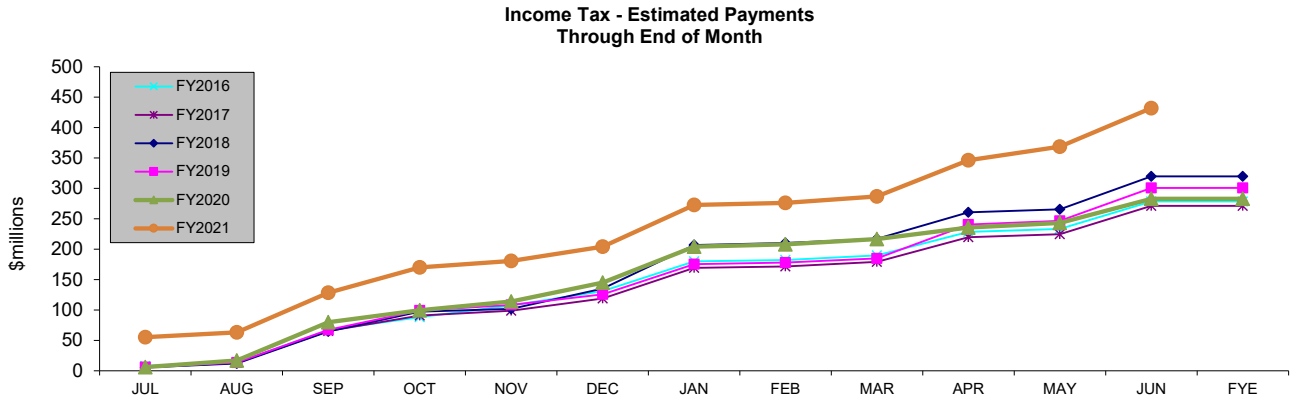

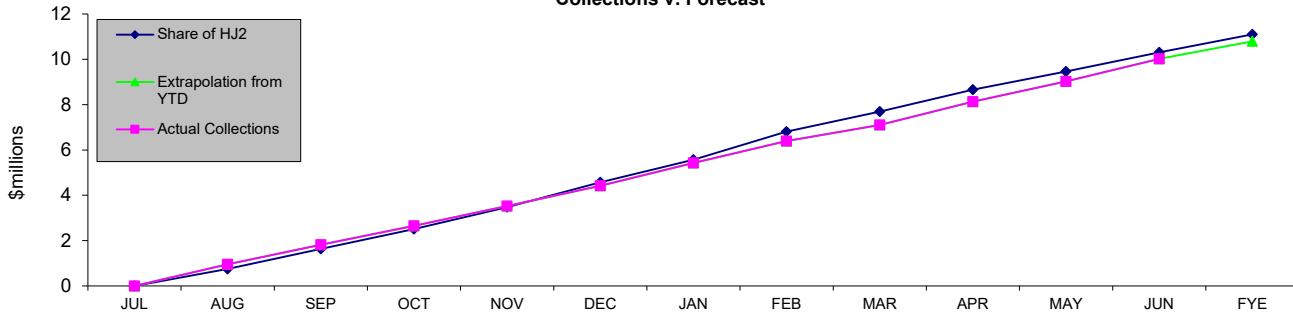

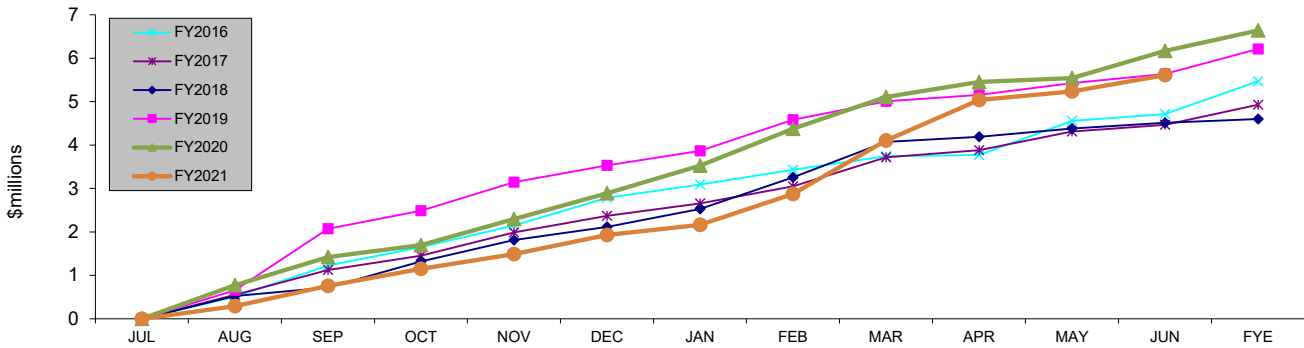

### Income Tax - Withholding Collections v. Forecast



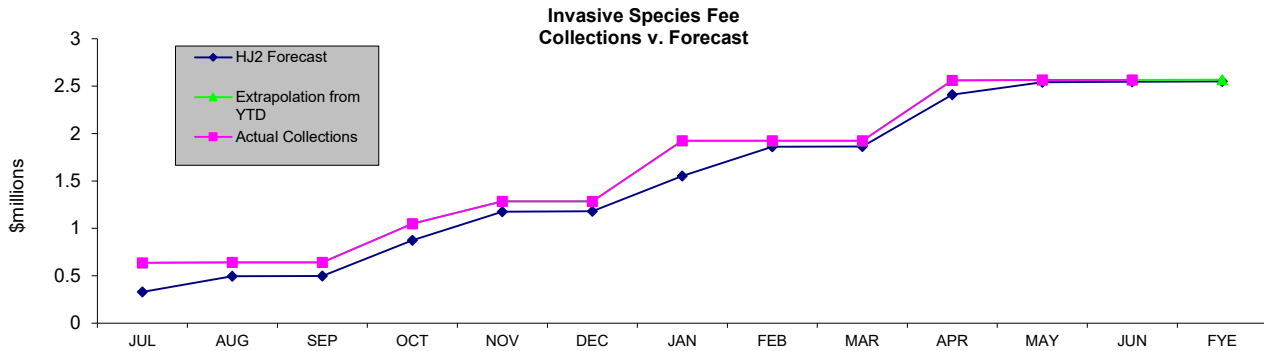
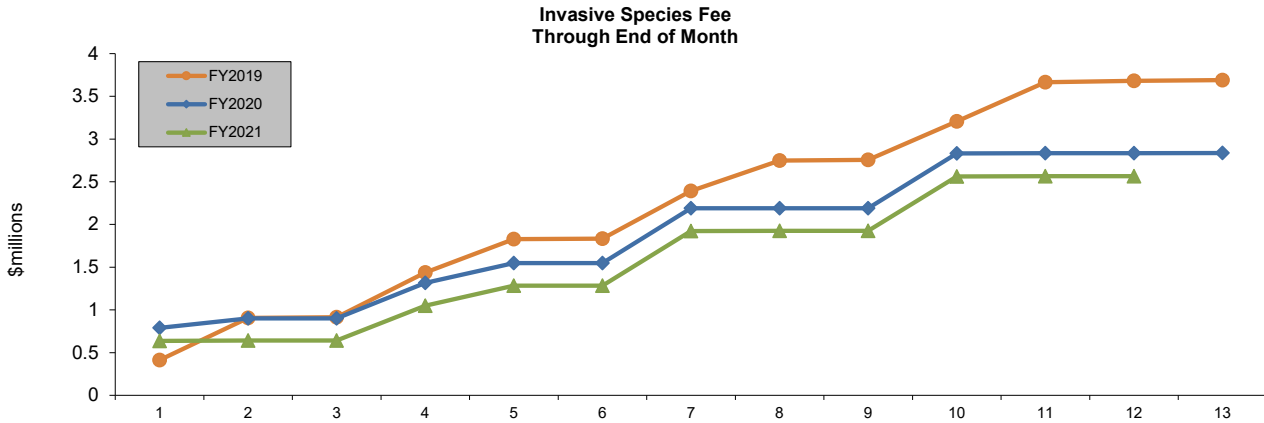

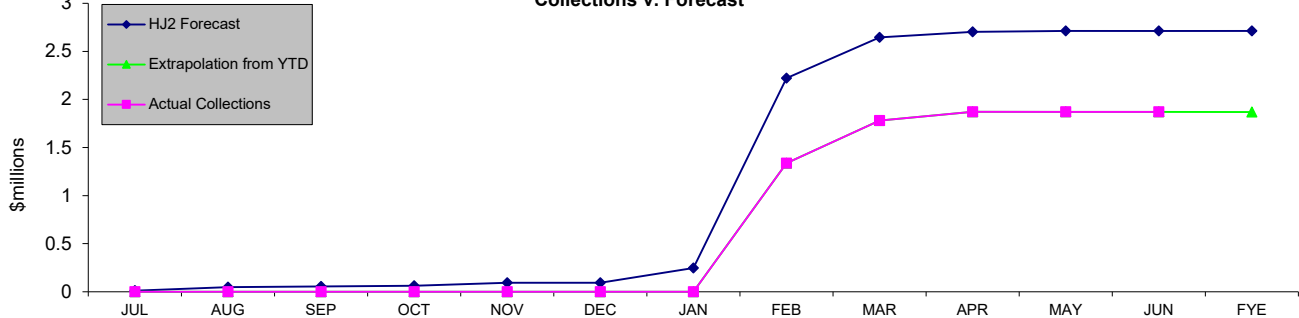

Collections v. Forecast**



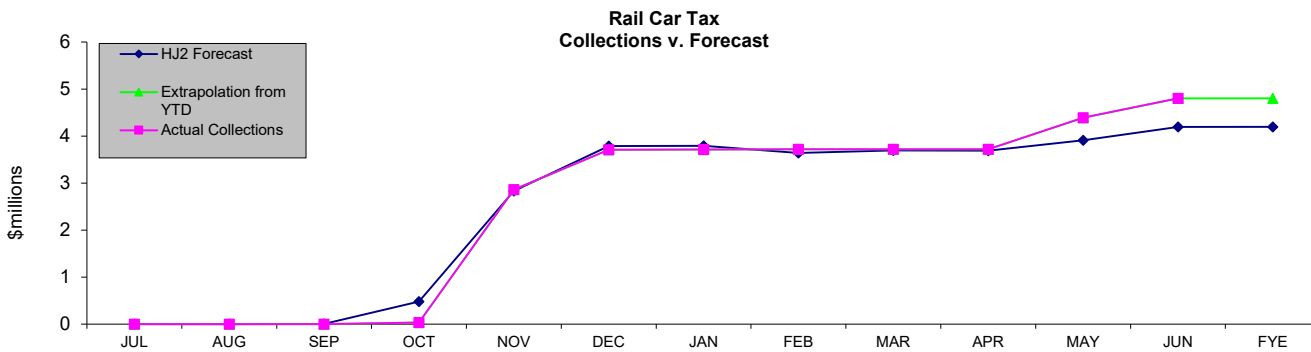
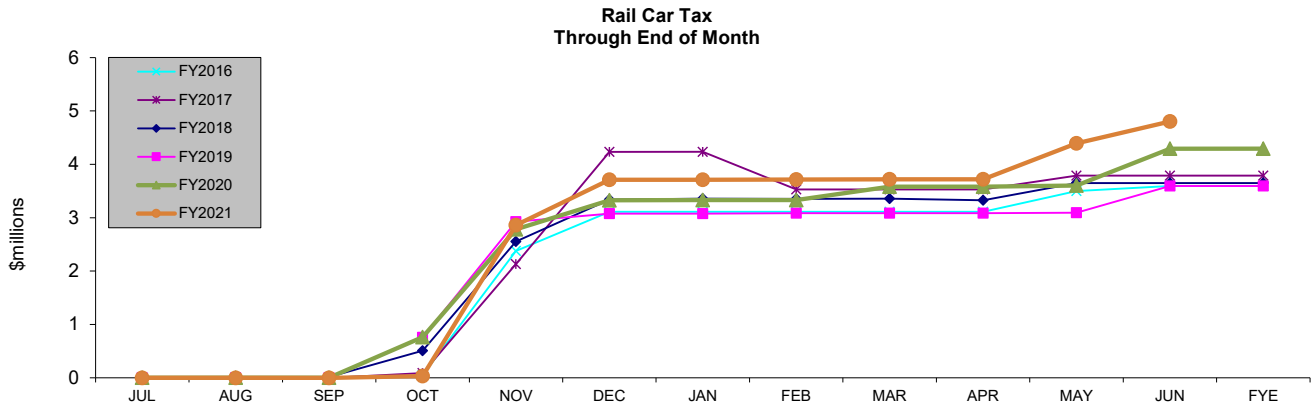

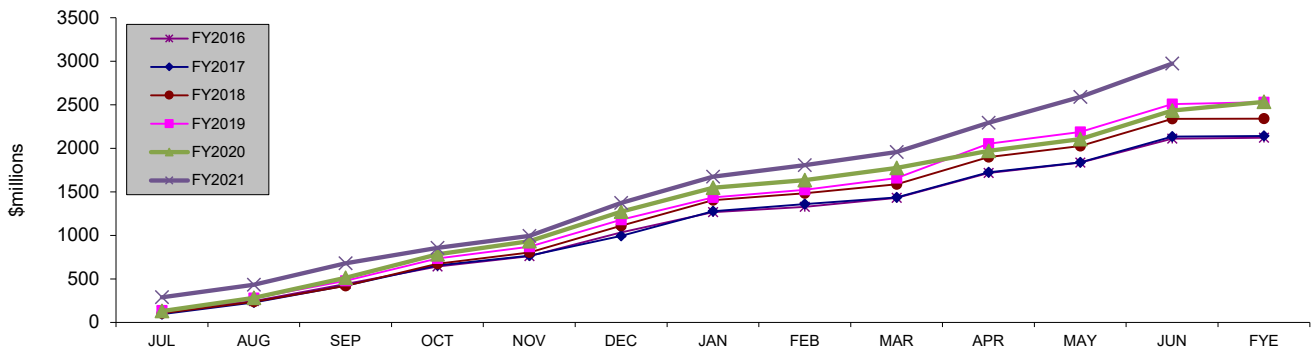

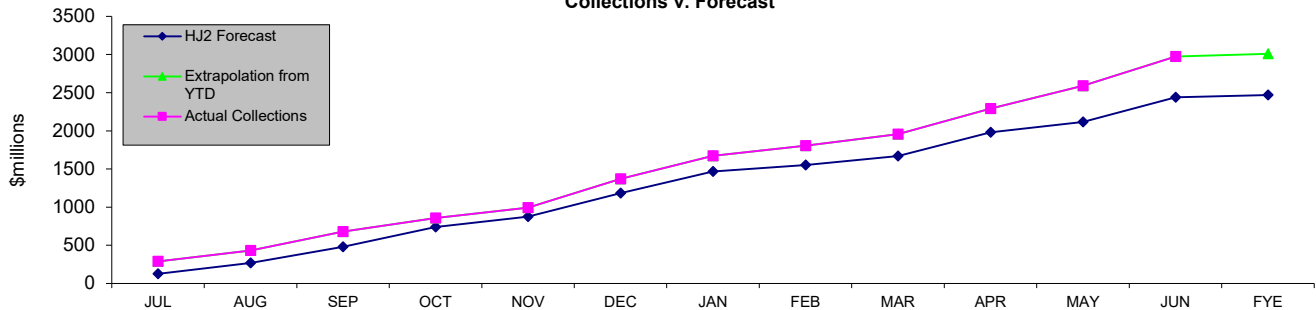
