Take the completed form to the local Department of Revenue county field office where the property is located. Go to https://revenue.mt.gov/contact/field-office-locations/ for local field office locations.

After processing the form, the Department of Revenue will return it to you (at the mailing address provided on page 1) with documentation showing the manufactured home has been taxed as real property for one year.

Take the returned form and documentation to the county clerk and recorder's office where the manufactured home is located.
