Cannabis & Alcohol Regulation Division (CARD) is pleased to offer five, one-time, \$2,000 scholarships for Montana seniors graduating high school in 2026. Please complete the following application form. Incomplete applications will not be considered. How is this possible? CARD is a member of the National Alcohol Beverage Control Association (NABCA) and received an alcohol education award from this organization. NABCA's mission is to support member jurisdictions in their efforts to protect public health and safety and ensure responsible and efficient systems for beverage alcohol distribution and sales.

The original artwork design will be used to promote responsible alcohol consumption across Montana. The designs will have a consistent theme centered on Montana and the tagline "Alcohol Responsibility Matters" along with the student's original designs. These messages will remind individuals 21 and over of the importance of being responsible when consuming alcohol. This will support the overall theme of Alcohol Responsibility Matters year-round. These designs may be used to create posters, T-shirts, stickers or decals, coasters, etc.

All scholarship applications must meet the minimum requirements which include the following:

- A complete and legible scholarship online application or mailed in and submitted by the deadline (January 25, 2026, by midnight). Applications must be mailed and postmarked by January 2, 2026.
- Current Montana student with a status of high school senior at the time of application.
- Proof of acceptance or personal letter of intent to attend any Montana post-secondary school/apprentice program/certificate institute of higher learning.
- The recipient will use the one-time scholarship funds for the 2026-2027 academic year.

Applications will open on December 1, 2025, and close on January 25, 2026, at midnight
